Globally, comparative analysis reveals both unity and variation. In post-genocide Rwanda, poets like Scholastique Mukasonga weave trauma into lyrical meditation, their verses a collective road through memory and recovery. In India, amid rising authoritarianism, writers such as Arundhati Roy and the collective “Poets for Peace” deploy satire and myth to challenge state narratives, their poems mapping resistance through allegory. In the Arctic, Inuit poets like Christi Belcourt reclaim

land-based knowledge through verse, their work a counter-road to extractive capitalism, rooted in ancestral relationships with ice, reindeer, and sky. Dalton’s *Poemas de la Resistencia* traced the road

through rural guerrilla camps and urban slums, each line a marker, each stanza a compass. In Chile, pre-Pinochet, poets such as Pablo Neruda—though later co-opted by the state—began experimenting with fragmented, mythic forms that prefigured later resistance writing, their verses laying groundwork for a generation that would walk a more explicitly defiant path. These early experiments were not isolated. They formed a transnational current, linked by shared experience of upheaval and a common rejection of narrative control. The economic dimensions of this resistance are critical. Structural adjustment programs imposed by the IMF and World Bank in the 1980s and 1990s deepened poverty and inequality across the
