Long-term implications point toward a reconfiguration of urban power. This critique spurred methodological innovation: the 2018 Nairobi Urban Justice Project employed ethnographic mapping and participatory GIS to redefine “environmental quality” through resident-defined indicators, including safety from violence, access to informal education, and social trust. Technological advancement further transformed the study. The proliferation of IoT sensors, satellite imagery, and AI-driven analytics enabled real-time monitoring of urban environments. Beijing’s Smart City initiative, for example, uses predictive algorithms to manage air quality, dynamically adjusting traffic flow and industrial emissions based on live pollution data.
