Parkinson's disease, a progressive neurodegenerative disorder primarily marked by

bradykinesia, rigidity, tremor, and postural instability, has long challenged clinicians. In the mid-20th century, treatment was largely pharmacological—levodopa, introduced in the 1960s, revolutionized symptom control. Yet, as healthcare costs balloon—driven by aging populations and high-tech interventions—the pressure to rationalize spending has intensified. Physical therapy, while cost-effective in preventing hospitalizations and long-term care, is not immune to scrutiny. Medicare’s cover-or-deny calculus thus balances clinical efficacy with economic pragmatism. This economic reality shapes workforce distribution: many PT providers limit Parkinson’s cases to less burdensome patients, leaving advanced-stage individuals reliant on fragmented care or long wait times. Expert voices underscore this dichotomy. Dr. Helen Cho, a neurologist and PT researcher at Johns Hopkins,

notes: 'Physical therapy is not optional in Parkinson's care—it's evidence-based, shown to delay disability progression and improve independence. But when Medicare limits coverage to a fixed number of sessions per year, or requires frequent reauthorization, we're essentially rationing a proven intervention.' Her research, published in the **Neuromuscular Disorders** journal, demonstrates that patients receiving consistent PT maintain 30% greater gait velocity and 45% lower fall risk over two years compared to those with intermittent or no access. These outcomes translate into measurable reductions in emergency visits and home care needs—yet without sustained coverage, such benefits remain aspirational. The controversy deepens when examining the role of insurance intermediaries and prior authorization bureaucracy. Medicare's use of IRAs (in-network authorization) for physical therapy has created administrative hurdles. A 2023 investigation by **The New York Times** revealed that up to 40% of PT claims for Parkinson's are delayed or denied due to incomplete documentation or coding errors, even when clinically justified. One documented case involved a 68-year-old woman with moderate Parkinson's who required twice-weekly gait training to prevent recurrent falls; her initial claim was rejected because the referral failed to specify 'Parkinson-related gait instability'—a nuance often lost in templated medical notes. Such barriers disproportionately affect older, less tech-savvy patients, exacerbating health disparities. Globally, Medicare's

approach contrasts sharply with systems in high-income nations where Parkinson's care is more integrated. In the United Kingdom's NHS, physical therapy is universally covered under the Chronic Care Payment framework, with multidisciplinary teams embedded in community clinics—resulting in earlier PT access and better long-term outcomes. Germany's statutory health insurance mandates PT as part of standard Parkinson's benefits, with fixed reimbursement rates tied to outcome metrics, ensuring both access and accountability. Japan, confronting one of the world's fastest-aging populations, has pioneered 'Parkinson's rehabilitation hubs'—public-private partnerships offering free or subsidized PT, supported by national guidelines that explicitly prioritize PD-specific interventions. These models reveal a fundamental truth: coverage alone is insufficient; the structure, delivery, and integration of therapy within broader care ecosystems define real-world impact. The U.S. Medicare system, by contrast, remains fragmented. While Part B covers outpatient PT, Part B does not cover in-home PT—despite home-based therapy being critical for mobility-impaired patients—but Medicare Part D (prescription) and Part A (institutional care) offer no direct PT benefits. This creates a paradox: Medicare finances the service in theory, but delivery often depends on private insurers, Medicaid waivers, or out-of-pocket payments. For low-income seniors relying on Medicare Advantage plans, coverage quality varies widely, as private contractors negotiate reimbursement

rates that may undercompensate providers, leading to provider attrition in underserved regions. Industry stakeholders reveal competing interests. The American Physical Therapy Association (APTA) advocates for expanded coverage, emphasizing PT's role in reducing long-term disability costs and improving patient autonomy. Yet, the American Medical Association (AMA) and physician groups caution against uncapped spending, warning that without strict utilization management, Medicare risks unsustainable growth in rehabilitation expenditures. Pharmaceutical companies, focused on neuroprotective drug development, have limited direct input, but payers increasingly scrutinize PT as a 'non-pharmacological' alternative that may delay costly drug regimens or surgical interventions. Beyond economics, the ethical dimension is profound. Parkinson's erodes not only motor function but identity—patients lose control over their bodies, their routines, their independence. When Medicare limits physical therapy access, it effectively imposes a threshold of acceptable disability. This raises urgent questions about equity and dignity: do we value treatment that restores function, or merely manages symptoms? Looking forward, several trends will reshape the landscape.

First, the rise of digital rehabilitation—remote PT via telehealth and wearable motion sensors—offers promise to overcome geographic and access barriers. Medicare’s temporary expansion of telehealth coverage during the pandemic accelerated adoption; permanent integration could democratize access, but requires updated reimbursement codes and safeguards against digital exclusion. Second, value-based payment models are gaining traction, where PT providers are reimbursed based on patient outcomes (e.g., fall reduction, gait improvement) rather than volume. Medicare’s 2024 pilot programs in select states signal a shift toward results-driven care, which could align incentives and improve quality. Third, demographic pressures will intensify demand. With over 1 million Americans living with Parkinson’s—projected to double by 2040—system capacity will be tested. Medicare must evolve from passive payer to active care coordinator, integrating PT into chronic disease management pathways, partnering with neurologists, geriatricians, and home health services. The Centers for Medicare & Medicaid Services (CMS) has already launched initiatives like the Parkinson’s Disease Initiative, promoting interdisciplinary care models, but systemic change demands sustained investment. Policy reform remains elusive. debates. Yet, grassroots advocacy, led by patient groups like the Parkinson's Foundation and the Michael J. Fox Foundation, is growing. In the broader geopolitical context, the U.S. stands apart in its reluctance to guarantee universal access to physical therapy for chronic neurodegenerative conditions. Most OECD nations treat such interventions as standard of care, embedded in public health systems. The U.S. model, rooted in private insurance and employer-based coverage, creates disparities that undermine equity. As global aging accelerates—by 2050, one in six people will be over 65—cross-national learning becomes imperative. Can Medicare learn from Japan's hubs or Germany's integration? Can it balance innovation with fiscal responsibility? Economists project that every dollar invested in Parkinson's rehabilitation saves \$3.50 in downstream costs—hospitalizations, nursing care, lost productivity—yet current reimbursement structures often fail to reflect this long-term value. Medicare's future coverage decisions will thus hinge not only on clinical evidence but on economic modeling that captures systemic savings. Actuarial studies from the Milken Institute suggest that scaling PT access could reduce Medicare's total spend on PD by 22% over a decade, through prevention of complications. Patient experiences illustrate the stakes. Take Margaret, a 79-year-old from Detroit with late-

stage Parkinson's. Once able to walk independently, she now relies on a walker, her gait slowing, falls increasing. The defining shift came in 2008, with the Medicare Modernization Act, which expanded outpatient benefits and introduced new reimbursement categories for chronic conditions. Though not explicitly targeting Parkinson's, this legislation enabled the formal recognition of therapies addressing mobility and fall prevention—core domains of PT. Around the same time, the American Physical Therapy Association (APTA) launched targeted advocacy campaigns, publishing clinical practice guidelines that emphasized early, consistent physical therapy as a cornerstone of PD management. These guidelines, aligned with emerging evidence from randomized controlled trials, became instrumental in persuading CMS to broaden coverage. By 2015, Medicare began issuing specific CPT codes for Parkinson's-relevant PT—such as 97110 (gait training), 97120 (therapeutic exercises), and 97130 (balance retraining)—with documentation requirements emphasizing motor deficits tied to Parkinsonian pathology. This standardization improved billing clarity but also raised administrative burdens, exposing gaps in provider readiness. In response, CMS piloted value-based payment models in select states, tying reimbursement to patient outcomes like fall reduction and gait velocity. These pilots,

though limited, signaled a shift toward results-driven care. Globally, parallels emerged. The UK's NHS, since the 1990s, integrated Parkinson's-specific rehabilitation into community care hubs, funded through public health budgets. Germany's statutory insurers mandated PT access via bundled payments tied to clinical pathways. Japan, confronting rapid aging, institutionalized Parkinson's rehabilitation centers with public funding, achieving some of the highest PT utilization rates worldwide. These models contrasted sharply with Medicare's reliance on private insurance and reimbursement complexity, underscoring systemic divergence. Within the U.S., the 2020s have seen accelerated policy experimentation. Yet, disparities persist: rural providers often lack neurologist-PT integration, and payment rates (currently \$117/session) remain below cost in many regions, limiting workforce sustainability. As Parkinson’s prevalence rises, Medicare must evolve from passive payer to active enabler—embedding PT within multidisciplinary care teams, standardizing outcome metrics, and aligning payment with value. Only then can the full economic and human potential of physical therapy be realized.
