Intelligence agencies must evolve from information gatherers to systemic orchestrators—capable of not only analyzing threats, but shaping the conditions in which they emerge. This requires investment in digital forensics, behavioral science, and AI ethics, as well as robust legal frameworks that balance security with civil liberties. The Codex also underscores the growing importance of epistemic sovereignty—the ability of societies to discern truth from manipulation. In an age where information is both currency and weapon, the battle is no longer just over territory, but over perception.
