Expert analysis revealed a spectrum of interpretation. Dr. Laura Benetti, a child development psychologist at the University of Bologna, emphasized that the exam's true innovation lay in its **formative** intent: not to grade but to refine practice. She noted that Montessori's original vision had always included systematic observation, but formalizing this into a structured assessment system allowed educators to build cumulative knowledge across classrooms. Conversely, Dr. Rajiv Mehta, a philosopher of education at Columbia University, cautioned that any exam risks reifying learning into discrete units, potentially distorting the fluidity of Montessori's holistic approach. The controversies were not merely academic. Though the case was dismissed on procedural grounds, it exposed structural weaknesses in global standard-setting bodies: limited representation from the Global South, divergent cultural understandings of the child, and the tension between universal standards and localized wisdom. Risks were equally pronounced. Critics warned that
