Companies like Purdue Pharma were dismantled, while others invested heavily in compliance and addiction monitoring systems. This shift has accelerated development of non-addictive painkillers, though progress is slow and constrained by patent regimes and profit incentives. The digital economy, arguably the most contested arena, has seen perhaps the most dramatic transformation. Social media platforms, once built on engagement-driven algorithms that reward outrage and addiction, now operate under mandates to limit harmful content, restrict data harvesting, and audit algorithmic bias. Meta’s rebranding to Meta Platforms and its investment in AI safety labs signal strategic adaptation, yet critics argue these measures are reactive and insufficient. The EU’s DSA imposes real-time transparency on content moderation and recommendation systems, effectively forbidding opaque manipulation—reshaping how tech firms design their products. Agriculture, too, is undergoing a paradigm shift. The European Union’s rejection of glyphosate and its push for organic farming have disrupted commodity markets, incentivizing agroecological alternatives. While large agribusinesses resist, smaller organic producers gain market share, though scalability remains an issue. In Brazil, deforestation-linked soy and cattle sales face growing prohibitions under international pressure, forcing supply chain traceability and sustainability audits.
