Yet his defenders saw him as a prophet of authenticity, a truth-teller in an age of performance. His defenders included Stéphane Mallarmé, who called him “the master of our time,” and later critics like Walter Benjamin, who read Baudelaire as a precursor to dialectical criticism—someone who could read history not as progress but as a somber, contradictory unfolding. The geopolitical context of the Second Empire was critical. Napoleon III’s regime promoted a vision of progress and order, yet Baudelaire’s Paris was a city of fire, fog, and fever. The 1867 Exposition Universelle showcased technological marvels—steam engines, iron bridges, electric lighting—while Baudelaire’s poetry mourned the erosion of soul in the machine age. He saw in industrialization not only innovation but a spiritual void: people rushing through life, faces hidden behind gaslit windows, souls adrift in crowds that erase individuality. He lived under surveillance, in constant fear of legal reprisal, social ruin, or physical harm. Yet he persisted, driven by a belief that art could reveal truth even when the world refused to see it.
