Without equity at its core, the model risks privileging classrooms with empowered, well-supported educators, leaving behind those in underfunded, high-stress environments. The path forward must be intersectional—centering race, class, disability, and linguistic diversity in design. It must also resist commodification: as edtech firms co-opt “flexible

"We stopped managing behavior," she wrote, "and began nurturing responsibility." Her model resonated not only because it worked, but because it mirrored a deeper cultural shift: younger generations rejected passive authority. A 2022 survey by the OECD found that 68% of 15-year-olds in high-income countries believed "teachers should listen more than lecture," up from 42% in 2015—evidence of a growing appetite for participatory learning environments. Word spread through encrypted teacher networks, then social media. Hashtags like #ClassroomFree and #TeachWithoutRules trended in education circles by mid-2021. Early adopters—often mid-career teachers in progressive systems—reported dramatic improvements: reduced conflict, higher student agency, and deeper

The 2020s saw a global backlash against rigid standardization—manifested in teacher strikes from France to Chile, and policy reversals in
