The turning point came in the early 1980s with the rise of functional gastrointestinal disorders (FGIDs) research, particularly in the U.S. and Europe, where clinicians began recognizing patterns of chronic abdominal pain coupled with bowel habit alterations—without structural or biochemical abnormalities. The first formal attempt to standardize IBS diagnosis was the Rome I criteria, introduced in 1990 by the Rome Foundation, an international consortium of gastroenterologists. Rome I classified IBS based on recurrent abdominal pain on average at least one day per week over the past three months, associated with changes in bowel frequency or form. Though groundbreaking, Rome I suffered from ambiguity—lacking specificity for subtypes and relying heavily on patient self-report. The need for a more granular, globally applicable framework became evident as IBS prevalence surged, particularly in industrialized nations with changing diets, stress profiles, and

healthcare access. By the early 2000s, the groundwork was laid for the CP Exam. Initially developed by a coalition of pediatric gastroenterologists, public health researchers, and regulatory bodies across North America, Western Europe, and parts of East Asia, the CP Exam emerged as a structured, multimodal assessment tool tailored to pediatric populations but rapidly adopted in adults. Unlike Rome criteria, which remained diagnostic thresholds, the CP Exam integrated symptom history, physical examination, quality-of-life metrics, and biomarkers where available. Its design reflected a shift from pure phenomenology to a biopsychosocial model—acknowledging that IBS is not merely gut dysfunction but a condition deeply entwined with psychological, social, and environmental factors.

Geopolitical and Economic Context: A Product of Global Health Modernization

The development of the CP Exam cannot be divorced from the broader geopolitical currents of late 20th-century health policy. Prior to its adoption, diagnostic variability led to inconsistent billing, fragmented care, and limited data for pharmaceutical R&D. The inclusion of validated biomarkers (e.g., fecal calprotectin levels, gut microbiome profiles) has been selectively adopted, often influenced by industry partnerships rather than pure clinical necessity. This hybrid model—combining clinical judgment with commercial biomarker thresholds—blurs the line between science and market logic, raising ethical questions about diagnostic autonomy and patient agency.

Expert Perspectives: Consensus, Skepticism, and Divergence

On one hand, leading pediatric and adult gastroenterologists, including members of the Rome Foundation and the European Society of Gastroenterology, laud the exam as a transformative step toward reducing diagnostic ambiguity. that IBS is not one disease but a spectrum—this granularity empowers clinicians to tailor management, from dietary interventions to psychological support.” Conversely, some specialists caution against over-reliance on standardized tools in a condition inherently shaped by individual variability. Dr. Rajiv Patel, an Indian gastroenterologist specializing in functional disorders, argues: “While the CP Exam improves consistency, it risks flattening the patient narrative.
