The thirteen colonies, born from British mercantilist structures and indigenous displacement, coalesced during the Revolutionary War not merely as a rebellion against imperial taxation but as a foundational act of political self-definition. The Declaration of Independence in 1776 was not only a rupture with Britain but a philosophical manifesto—one that invoked natural rights yet simultaneously excluded women, enslaved Africans, and Native peoples from its universal promise. As historian Gordon Wood observes, the Revolution created a “new kind of republic” grounded in consent and civic virtue, but its architecture was fundamentally shaped by elite interests and racial hierarchies. The Constitution, ratified in 1788, formalized this tension: a federal system designed to balance state sovereignty with national cohesion, yet embedded with compromises—most notably the Three-Fifths Clause and the fugitive slave provisions—that sanctified slavery within the legal framework. The 19th century marked the United States’ emergence as a continental power through war, displacement, and industrialization.
