A 2021 comparative study in Kenya found that ABA-based interventions, when introduced without adaptation, led to increased student anxiety and resistance, perceived as dehumanizing by both educators and caregivers. Advocates urge a paradigm shift from behavior modification to neuroaffirming practices—interventions that respect autistic identity, prioritize self-determination, and redefine success beyond compliance. Policy makers face a critical juncture: whether to continue funding ABA as the primary behavioral intervention or to redirect investment toward holistic, inclusive models that value diversity as strength. Early evidence from Finland's inclusive schools suggests that such investment yields higher long-term educational outcomes and greater social cohesion. By 2040, the classroom may witness a synthesis: ABA's rigorous data structures fused with trauma-informed care, sensory design, and student-led goal setting. The most effective models will likely be those that balance behavioral efficiency with human dignity—where measurement serves empowerment, not just compliance.
