Simultaneously, countries like Brazil and India were reforming social security and pension systems, demanding more granular, auditable payroll tracking. In Southeast Asia, the ASEAN Economic Community's push for regional integration created a demand for seamless cross-border payroll solutions. Multinational firms operating in multiple ASEAN states needed a single platform that could reconcile divergent tax treaties, VAT regimes, and mandatory benefit contributions—none of which Direct2HR had ignored. The platform's modular design allowed it to be localized not just linguistically, but legally: in Thailand, it embedded strict mandatory pension contributions; in the Philippines, it integrated Overseas Workers' Welfare Administration (OWWA) compliance.
