Berlin offers a contrast: a unified, subsidized fare system with free transfers, funded by progressive taxation, ensuring transit remains accessible regardless of income. Paris integrates transit payment into broader digital identity systems, enabling seamless, inclusive access.

But even in progressive models, tensions persist. New York's "Fair Fares" program offers reduced fares to low-income riders, yet enrollment remains low due to bureaucratic hurdles. Chicago's EBT (Electronic Benefit Transfer) card pilot, allowing transit use with SNAP benefits, shows promise—over 120,000 riders enrolled by 2024—but scalability depends on state-level support and federal funding.

Long-Term Implications and Strategic Outlook

Looking ahead, Chicago's ticket payment system stands at a crossroads.
