Beyond CAR-T, BMS explores bispecific T-cell

engagers (TCEs) and natural killer (NK) cell therapies, reflecting a broader strategic bet on multi-modal cellular interventions. The company's investment in gene-editing infrastructure—including partnerships with CRISPR Therapeutics and internal genome editing centers—positions it at the forefront of next-generation cell design, where precision, safety, and scalability converge.
