Plutonium and uranium compounds, central to nuclear reactors and weapons, represent both a triumph of nuclear chemistry and a persistent security threat. The dual-use nature of inorganic materials—benign in one context, catastrophic in another—forces chemists and policymakers into a fraught ethical calculus. Tuli cites the IAEA's ongoing challenges in monitoring enrichment facilities, where centrifuge technology and chemical separation processes blur the line between energy production and weapons development. The field's power to create is inseparable from its potential to destroy—a duality that demands transparency, international cooperation, and rigorous safeguards.

Global Comparisons: Divergent Trajectories in Inorganic Chemistry Development

Tuli's comparative analysis reveals stark contrasts in how nations cultivate inorganic chemistry expertise. In the United States, a combination of private sector innovation, federal funding through agencies like the NSF and DOE, and strong university-industry linkages has sustained leadership in advanced materials and catalysis. Germany's Fraunhofer model exemplifies applied research excellence, translating lab breakthroughs into industrial applications. In contrast, China's state-driven strategy—investing billions in rare earth processing, high-
