This stage reveals the interplay between innate linguistic blueprints—Noam Chomsky’s Universal Grammar—and environmental input. From 2 to 3 years, linguistic complexity explodes. Children master noun-verb differentiation, begin using plurals and past tense, and engage in simple conversations. While screen-based learning offers access, excessive passive consumption—especially uninteractive apps—correlates with delayed expressive language, particularly in children under 3. The American Academy of Pediatrics recommends limiting screen time for young children, prioritizing live, responsive

interaction as irreplaceable for language growth.

Global Comparisons: Cultural Variability and Learning Ecologies
