Market Influence captures a country’s capacity to sway prices through production adjustments, leveraging order book analysis, futures market positioning, and cartel behavior patterns. This multidimensional scoring has transformed energy markets from passive price takers into active, algorithmically informed agents. For example, Saudi Arabia’s Abas II score surged post-2022 as its Vision 2030 infrastructure investments and diversified export routes reduced its vulnerability to Gulf-specific disruptions. Conversely,

nations like Venezuela and Nigeria saw sharp declines due to chronic underinvestment, sanctions evasion complexities, and internal instability—even when crude output remained high. Abas II does not merely reflect reality; it anticipates it, embedding forward-looking risk assessments that guide trillions in energy finance annually.
