While Hersh exposed war crimes through undercover reporting, and Poitras revealed surveillance via encrypted channels, Paulson mapped the invisible infrastructure enabling global opacity. Her work was less about singular scandals than systemic transformation—paving the way for the Panama Papers, Paradise Papers, and subsequent reforms. Economically, Paulson’s contributions are measurable. Between 2000 and 2015, over 120 countries adopted automatic exchange of financial information, a direct outgrowth of the transparency frameworks she helped design.
