pressures from Central America and Asia—add strain to labor markets and social cohesion. Internally, political polarization in the U.S. and debates over Quebec sovereignty challenge the unity of the Canadian federation, raising questions about long-term stability. The 2022 Minerals Security Partnership, which includes Canada, the U.S., and seven additional democracies, exemplifies this trend—securing non-Chinese sources of lithium, cobalt, and rare earths essential for

green and defense industries. Military cooperation deepens through NORAD modernization, joint cyber defense exercises, and shared Arctic surveillance systems. The 2023 Canada-U.S. Defense Policy Review reaffirmed commitments to 2% defense spending targets and synchronized modernization of air and naval capabilities, particularly in response to Russian submarine activity in the Arctic and Chinese naval incursions in the Pacific. These efforts reflect a recognition that the political map's security is inseparable from technological edge and alliance cohesion. Yet, divergence persists. Canada's constitutional refusal to join nuclear-sharing agreements under NATO complicates U.S. strategic calculations, while Quebec's distinct foreign policy inclinations—evident in its diplomatic outreach to Francophone nations—highlight internal tensions in projecting a unified North American voice. Moreover, Canadian public opinion remains wary of deep entanglement in U.S.-led military interventions, a legacy of historical neutrality and recent experiences with Iraq and Afghanistan.
