Japanese researchers at Kyoto University’s Sleep Research Institute documented a striking correlation: patients with moderate-to-severe OSA exhibited significantly higher tinnitus severity scores, even after adjusting for age, gender, and baseline hearing loss. This led to the conceptualization of “tinnitus secondary to sleep-disordered breathing.” But diagnosis remained elusive. Traditional polysomnography—gold standard for OSA—was costly, inaccessible in many regions, and often normalized OSA as a benign condition rather than a systemic threat. Enter the CP exam. This global asymmetry reflects broader healthcare inequities. Studies using fMRI and EEG have shown that OSA patients exhibit reduced activation in the primary auditory cortex and heightened activity in stress-responsive regions like the amygdala and anterior cingulate—changes correlated with CP exam deficits.
