The Septuagint—Greek translation commissioned under Ptolemaic rule—expanded biblical reach into Hellenistic culture, enabling early Christian adoption and transmission. The New Testament, composed between 50–100 CE, reflects a rapidly shifting world: Roman occupation, Jewish sects (Pharisees, Essenes, Zealots), and urban centers like Antioch and Corinth. Its letters, attributed primarily to Paul, articulate theological innovations—justification by faith, universal salvation—while navigating tensions between Jewish law and Gentile inclusion. The canonical process accelerated post-70 CE, following the destruction of

the Second Temple, as rabbis formalized the Torah, Nevi'im, and Ketuvim into a fixed Hebrew canon, reinforcing religious continuity amid fragmentation.

The Quran's textual genesis stands in stark contrast. Described by Muslims as the literal, uncreated word of God revealed to Muhammad over 23 years (610–632 CE), its transmission relied on oral recitation and early written records. Muhammad received revelations in Arabic, a language with rich poetic and rhetorical traditions, shaping the Quran's distinctive linguistic style—rhythmic, repetitive, and deeply evocative. Unlike the Bible's gradual accretion, the Quran's textual integrity was prioritized early: scribes memorized verses (hifz), and under Caliph Abu Bakr, Zayd ibn Thabit compiled surviving fragments into a standardized manuscript, later preserved under Uthman in the Uthmanic codex (c. 650 CE). This early standardization prevented textual variation, reinforcing the doctrine of Quranic inerrancy.

Archaeological and paleographic evidence reveals subtle textual variations in early manuscripts, yet these remain within the bounds of intentional scribal preservation rather than corruption. The Dead Sea Scrolls, though pre-dating the biblical canon's finalization, confirm remarkable textual stability in prophetic texts, suggesting a robust oral and scribal

tradition. In contrast, Quranic manuscripts—some dating to the 7th and 8th centuries, including palimpsests from Sana'a—display minimal variation, preserved through oral recitation (tajwid) and communal memorization. Digital analysis confirms that over 99% of extant Quranic manuscripts align with the Uthmanic standard, underscoring a deliberate effort to safeguard divine wordhood.

The structural differences in composition further distinguish the two texts. The Bible is a composite, evolving from genealogies and tribal laws to prophetic oracles and epistolary wisdom, reflecting diverse authorship, genres, and historical contexts. Its books vary widely—historical, poetic, legal, philosophical—mirroring shifting communal needs and theological debates. By contrast, the Quran presents a unified revelatory chronology, organized into 114 chapters (surahs) by length rather than theme, with each revealing God's guidance through Muhammad's lifetime. Its discourse weaves legal injunctions, moral exhortations, cosmological reflections, and eschatological warnings into a coherent theological framework.

Geopolitical forces deeply influenced both texts. The Bible's formation unfolded amid Assyrian and Babylonian empires, whose deportations scattered

Israelite communities and reshaped religious identity. The Gospel of Mark, likely written in Rome under Nero, reflects early Christian marginalization, while Paul's letters engage Roman legal culture, appealing to universal reason and imperial citizenship. The New Testament's spread accelerated with Roman roads and Greek as a lingua franca, embedding scripture in Mediterranean intellectual life.

The Quran, emerging in 7th-century Arabia, responded to a tribal, polytheistic society fragmented by intertribal warfare and economic inequality.

Revelations addressed both spiritual renewal and social cohesion: injunctions against theft, injustice, and usury (Quran 2:188–191) challenged tribal norms, while affirmations of monotheism (tawhid) united disparate groups under one divine authority. The Quran's emphasis on zakat (almsgiving) and justice anticipated Islamic economic systems, later institutionalized in medieval waqf (endowment) networks and modern sharia-compliant finance.

Textual authority in both traditions evolved differently. The Bible's canon was shaped by ecclesiastical councils (e.g., Carthage, Trent), reflecting theological consensus and institutional power. The Protestant Reformation challenged papal authority by returning to original Hebrew and Greek texts, privileging

individual scriptural interpretation. In Islam, the Quran's textual integrity was safeguarded through oral recitation and scholarly verification, with the science of tajwid codifying pronunciation rules to preserve divine phonetics. Yet Islamic jurisprudence (fiqh) developed flexible methodologies—ijtihād, qiyas—allowing adaptation across cultures, unlike the Bible's more rigid canonical boundaries.

Scholarly methodologies reveal divergent approaches to textual authority. Biblical studies integrate archaeology, textual criticism, and historical analysis, often questioning literalism in favor of contextual hermeneutics. Islamic scholarship, rooted in tafsir (exegesis), combines linguistic precision (qira'at), hadith authentication, and theological reflection, with classical works like Al-Tabari's tafsir blending historical narrative and Quranic interpretation. Controversies persist, especially regarding historical accuracy. Biblical archaeology confirms cities like Jerusalem and Jericho but offers limited evidence for

major events like the Exodus or Davidic kingdom—prompting debates between minimalist and maximalist interpretations. The Quran’s historical claims—Muhammad’s revelations, battles of Badr and Uhud—are largely accepted within Muslim tradition, though scholarly analysis examines their historical context and literary development. Both texts navigate tensions between divine revelation and historical critique, demanding nuanced engagement.

Economically, both scriptures shaped systems of production and exchange. Biblical teachings on stewardship and justice influenced medieval Christian attitudes toward labor and charity, while Protestant ethics linked diligence and frugality to divine favor. The Quran’s injunctions against *riba* (usury) catalyzed Islamic financial innovation—profit-sharing, risk-sharing models—giving rise to a trillion-dollar global Islamic banking sector.
