The U.S. model underscores a fundamental tension: standardization enhances safety and efficiency, yet risks homogenizing local needs and capacities. Emerging economies face a dual challenge. On one hand, adopting global COM standards attracts foreign investment and aligns with international development goals. On the other, rigid frameworks can marginalize informal labor sectors and local knowledge.
