The Global Fund's **Health Systems Strengthening** initiative funds open-access curricula in high-burden countries, aligning with its mandate to reduce preventable deaths. Gavi, the Vaccine Alliance, has expanded its mandate to include broader

immunization safety training, recognizing that error-free administration underpins vaccine efficacy. Yet private sector involvement remains significant—and contentious. Companies like Novartis, Roche, and Johnson & Johnson sponsor or co-develop open training modules, often under corporate social responsibility (CSR) banners. These partnerships offer dual benefits: they enhance training quality through industry expertise and provide corporations with early market insights and reputational capital. However, critics warn of potential conflicts of interest—where training content might subtly favor proprietary products or obscure liability risks. The *WHO Guidelines on Public-Private Engagement in Health Education* (2021) attempt to mitigate this by requiring transparent funding disclosure and independent content review, but enforcement remains uneven. Philanthropy plays a catalytic role. The Bill & Melinda Gates Foundation, through its *Global Health Program*, has funded over 40 open-access training initiatives, including the *Community Medication Safety Network* in East Africa. These investments are not altruistic vacuum cleaners; they advance strategic health security goals, reduce long-term public health costs,
