India’s role as a global supplier of radiopharmaceuticals—particularly through private pharmaceutical firms—positions it as both a consumer and producer, though regulatory harmonization across South Asia remains fragmented. In Africa, nuclear medicine is nascent. Only South Africa, Nigeria, and Kenya operate cyclotrons or PET scanners. The IAEA’s “Programme of Action for Cancer Therapy”
