These artifacts are not arranged chronologically in isolation, but thematically—under “Land and Labor,” “Community and Conflict,” “Change and Continuity”—inviting visitors to see connections across time. A pivotal moment came in the 1990s, when the museum confronted the fraught history of racial segregation and labor exploitation. Exhibits on the Bessemer Cotton Mill, once a site of brutal working conditions, were reinterpreted through survivor testimonies, union records, and archaeological soil analysis that revealed
