Fine dining establishments began integrating “unplated” service models, where dishes emphasized raw ingredients and open preparation, echoing the book’s aesthetic. Meanwhile, fast-casual chains adopted simplified menus centered on seasonal, locally sourced items—often traceable via QR codes linking to short instructional videos inspired by Moreau’s framework. Yet resistance persisted. Culinary purists lamented the dilution of technique into algorithm-driven guidance, warning that automation risked eroding the improvisational creativity central to cooking as art. Labor unions for chefs expressed concern that simplified methods might devalue expertise, particularly in regions where culinary training is a pathway to economic mobility.**

Expert Perspectives: From Culinary Thinkers to Behavioral Scientists

food trends, asserting that sustainability and authenticity are rooted in place-based knowledge. In contrast, in high-tech hubs like Singapore and Tokyo, the movement evolved toward robotic assistive kitchens integrated with AI coaches—where precision cooking is enhanced, not replaced, by technology.
