Lovaas’s work was controversial: critics questioned the intensity of interventions, the use of aversive stimuli (later largely phased out), and the generalizability of results. Yet, his findings were methodologically rigorous, generating a corpus of peer-reviewed data that could not be ignored. Lovaas’s influence extended beyond clinical psychology. In India, where autism prevalence estimates range from 1:100 to 1:300, limited access to trained professionals and stigma surrounding neurodevelopmental conditions constrain widespread adoption. Nevertheless, NGOs and private clinics increasingly adopt ABA-inspired models, often through telehealth platforms that bypass infrastructure gaps. In Brazil, public health initiatives have piloted ABA-based early intervention programs, supported by federal funding for autism services—a rare case where national policy embraces behavioral science as a tool for inclusion. The handbook’s adaptation to these diverse contexts reveals a paradox: while its technical core remains consistent, its application is deeply contingent. In Germany, ABA practitioners must navigate strict data privacy laws under GDPR, requiring transparent consent and minimal data retention. These localized adaptations challenge the
