Countries along BRI corridors—from Kenya to Cambodia—now host joint TCM research centers and herbal processing hubs, creating a Sinocentric supply chain. Yet, this expansion has sparked debates over intellectual property and biopiracy. Indigenous communities in Yunnan, for instance, report unauthorized extraction of **Piper baventinii** and **Gynostemma pentaphyllum** for mass-scale production, with profits flowing predominantly to corporate entities rather than source communities.

India's Ayurveda and Unani systems, officially recognized under the 2023 National Health Policy, benefit from government subsidies and a growing domestic market. However, the sector struggles with fragmentation: only 12% of Ayurvedic firms meet WHO's Good Manufacturing Practice (GMP) standards, and export compliance remains inconsistent. India's ambition to become a global herbal hub faces hurdles in harmonizing traditional formulations with Western clinical trial requirements. Meanwhile, African nations, despite rich biodiversity, lag due to weak regulatory infrastructure. This fragmentation extends to intellectual property (IP). The Nagoya Protocol (2014) mandates fair benefit-sharing for genetic resources, yet enforcement is weak. Bioprospecting firms often extract botanical samples from biodiverse nations without compensating source communities, perpetuating historical inequities. The case of *Rauvolfia serpentina*, used in Ayurveda for hypertension, illustrates this tension: while its active alkaloid reserpine is patented globally, Indian farmers receive no royalties, despite the plant’s cultural and ecological significance.
