Policy experts like Dr. Linda Darling-Hammond stress systemic change over individual behavior. As president of the Learning Policy Institute, she advocates for reducing class sizes, increasing teacher salaries, and embedding mental health professionals in schools. Her data-driven approach shows that schools with robust support systems report 30% lower rates of disciplinary referrals. Still, political will and funding remain inconsistent, particularly in nations prioritizing standardized testing over holistic development.
