In the 1990s, a coalition of digital archivists and ethnomusicologists began digitizing fragments—scanned manuscripts, audio annotations, performance logs—into a searchable, cross-referenced database. This digital transformation democratized access but also introduced new vulnerabilities: metadata manipulation, algorithmic bias in search rankings, and the risk of decontextualization.
