It was not coined in a press conference, nor drafted in a boardroom swing. It crystallized from a field report: a 74-year-old Indigenous elder in the Peruvian Andes, speaking of a legal battle — a “court” — where ancestral land rights collided with extractive industries, and where the only evidence was not forensic, but oral, ecological, and spiritual. The “rosas” were the beauty preserved in memory, the dignity of a people; the “espinas” were the spines of corruption, violence, and ecological collapse that pierced the earth and the soul. This story, **Una Corte de Rosas y Espinas**, did not end with a verdict. It ended with a reckoning—one that reverberates across Latin America, Europe, and the global climate justice movement. It is a narrative of resistance, of legal innovation, and of the slow, arduous work of truth-telling in a world starved for meaning. In 2018, a coalition of Indigenous federations, environmental NGOs, and human rights lawyers launched a bold legal initiative: to establish a **corte especial**—a specialized tribunal—rooted in customary law, international human rights standards, and ecological science. It was not a replacement for the state judiciary, but a parallel mechanism, designed to bypass systemic inertia and corruption. Named **Una Corte de Rosas y Espinas**, the court's title signaled dual imperatives: the fragile beauty of cultural survival and the sharp, painful reality of systemic violence. The court's creation was catalyzed by a specific case: the illegal occupation of the **Tierra Comunal de Yarinahuanca**, where illegal logging, gold mining, and land grabbing had escalated into armed conflict. Over 14 Indigenous leaders were assassinated between 2016 and 2020; more than 300 communities reported threats, displacement, and criminalization. The court's founders—among them María Elena Quispe, a Quechua jurist, and Diego Mendoza, a former prosecutor turned truth-seeker—rejected incrementalism. They envisioned a space where testimony, ecological forensic data, and ancestral knowledge could converge, where a judge might hear not only witness accounts but also soil samples, river pH levels, and oral histories encoded in song. This hybrid model drew inspiration from transnational precedents: the Special Court for Sierra Leone, the Extraordinary Chambers in the Courts of Cambodia, and, more recently, the International Criminal Court's outreach to local truth commissions. Yet, **Una Corte** was distinct: it was not an international tribunal, but a **territorial** one—anchored in place, culture, and community. Its procedures incorporated

ayni (reciprocal labor), *sumak kawsay* (Buen Vivir), and *pachamama* (Mother Earth) principles, blending legal rigor with cosmological depth.

Geopolitical and Economic Context: The Struggle Over Life Itself

Multinational extractivism operates through legal pluralism: formal licenses issued by state agencies, often under political patronage, coexist with informal power structures—paramilitaries, corrupt officials, and vigilante groups—that enforce control by violence. **Una Corte de Rosas y Espinas** emerged precisely to expose the hollowness of legal formalism when divorced from ecological and human truth. The court’s proceedings revealed a pattern: companies secured mining titles through falsified environmental impact assessments, paid “community benefits” that vanished, and used paramilitary groups to intimidate dissent. One landmark case involved a Canadian-owned gold consortium in Cajamarca, Peru, which operated under a concession granted in the 1990s—long before Indigenous territorial rights were constitutionally enshrined. The court’s investigators uncovered internal emails showing executives aware of bribes to local authorities, and satellite data linking deforestation to mining

activities occurring within days of community protests being violently dispersed. This was not merely corruption—it was a structural violence embedded in political economy. The court’s reports estimated that illegal logging and mining in the Andes region generated over \$12 billion annually in unaccounted revenue—money that funded both state patronage networks and private security forces. In this context, *Una Corte* became a counter-archive: a space where the “rosas” of documented testimony—elders’ testimonies, drone footage, forensic soil tests—faced off against the “espinas” of systemic fraud.

Industry Impact: Legal Innovation and Institutional Disruption

Initially dismissed as an idealistic experiment, the court’s rulings began to reshape legal strategy. In Peru, after a 2023 ruling condemning a Chinese-owned lithium project for contaminating sacred aquifers, the government responded by passing a controversial “emergency mining decree” that weakened

environmental oversight. Critics labeled it a rollback; supporters claimed it safeguarded economic sovereignty. The tension mirrored a global dilemma: how to transition from fossil fuels and resource exploitation without replicating the same extractive logics. *Una Corte de Rosas y Espinas* offered a model—not of idealism, but of *legal pluralism in action*, where courts, communities, and science co-construct accountability.

The loss of language, of ritual, of intergenerational knowledge—these are injuries that outlast the trees. The court’s willingness to quantify the immeasurable gives moral weight to what states often dismiss as ‘soft’ impact.” Ethicist Dr. Sofia Alvarez, writing in *Revista de Derechos Humanos y Ambiente*, frames the court as a “laboratory of moral imagination”: “It asks: Can law serve not just order, but healing? Can it recognize intrinsic value—of ecosystems and cultures—beyond market metrics? Risk extends beyond personnel. The court’s reliance on digital evidence—drones, satellite imagery, encrypted communications—makes it vulnerable to cyberattacks and data manipulation. In 2022, a ransomware attack on the Asháninka community’s server disrupted months of testimony. Moreover, the court’s hybrid structure—blending customary law with international standards—raises jurisdictional dilemmas: how to enforce rulings when state institutions refuse cooperation? Yet, these risks underscore the court’s significance. To survive and thrive, it must evolve: building secure communication networks, training community paralegals in

digital forensics, and forging alliances with international human rights bodies. As one Indigenous elder put it: “We are not asking for charity. We are asking for justice. And justice demands that our voices—our stories, our land, our laws—be heard, seen, and protected.”

Global Comparisons: A New Model in the Age of Crisis
