By dismissing lived experience, historical trauma, and systemic inequality as

“subjective bias,” mainstream sociology marginalizes knowledges rooted in resistance, decolonization, and social struggle. For instance, Fanon’s **The Wretched of the Earth** exposes how colonial sociology, claiming neutrality, naturalized racial hierarchies and justified violence—all under the guise of scientific objectivity. The ideal is no longer to be value-neutral, but to be value-conscious—transparent about assumptions, accountable to affected communities, and committed to justice. The long-term implications are profound. If sociology abandons the myth of neutrality without replacing it with a more robust, ethical framework, it risks becoming irrelevant—caught between the demand for objectivity and the imperative for truth. Yet if it embraces a socially embedded, reflexive, and justice-oriented practice, it can reclaim its role as a vital public intellectual force. The challenge lies not in achieving a static neutrality, but in cultivating a dynamic, democratic epistemology—one that acknowledges the irreducible role of values while demanding their rigorous, transparent, and ethical deployment.
