heavy approaches of traditional Western schools, reinforcing M7's reputation for practicality. Similarly, in Southeast Asia, the ASEAN Economic Community (AEC) created a regional market requiring leaders with multilingual fluency, regulatory agility, and cross-border negotiation skills. The University of the Philippines' Andrew Young School, for instance, developed specialized tracks in Southeast Asian integration and sustainable development—areas often overlooked by global rankings but critical to national competitiveness.
