The 2001 anthrax attacks had exposed vulnerabilities in biological defense systems, prompting a wave of investment in biosurveillance and pathogen analytics. The U.S. Intelligence Community, particularly the Defense Intelligence Agency (DIA) and the National Institutes of Health (NIH), initiated a classified program codenamed "P3 Initiative"—an acronym reflecting its tripartite focus: Pathogen identification, Performance benchmarking, and Predictive risk modeling. Lab P3 emerged as the analytical core of this initiative, designed to process high-dimensional genomic datasets through machine learning algorithms capable of detecting

anomalous biological patterns.
