The pharmaceutical industry, too, is recalibrating. Traditional weight-loss drugs like semaglutide (Ozempic) are now part of a broader metabolic optimization ecosystem, with emerging therapies targeting insulin sensitivity, gut microbiome balance, and neuroinflammation. Biotech firms such as Viome and DayTwo are pioneering microbiome-informed nutrition, where dietary recommendations are dynamically adjusted based on individual biological data. Yet this innovation is not without friction. The rise of “quantified self”

technologies raises ethical concerns: data privacy, algorithmic discrimination, and the potential for health surveillance. A 2024 report by the OECD warned that without robust governance, personalized wellness could deepen health inequities, privileging those with access to technology and data literacy.
