However, environmental regulations in China—particularly stricter limits on sulfur dioxide and particulate emissions—have led to plant closures and consolidation, prompting multinational buyers to diversify sourcing to India, where methanol-based acetic acid is increasingly produced using natural gas feedstocks. The dyeing and pigment supply chain introduces further complexity. Cadmium-based reds and yellows, once standard, are now restricted under REACH and RoHS regulations due to their toxicity, forcing manufacturers to adopt alternatives like iron oxides or organic pigments. Iron oxide pigments are mined globally, with China, India, and Brazil supplying the majority. However, supply disruptions—such as India's 2021 export curbs on non-ferrous metals—highlight the fragility of this segment. Meanwhile, synthetic dyes derived from azo compounds are produced in clusters across South Korea, Germany, and the U.S., where environmental compliance is stringent but production costs are high. Plasticizers, essential for flexibility, reveal another layer of geopolitical exposure. Di-2-ethylhexyl phthalate (DEHP), historically preferred for its performance, is now restricted in many markets. Non-phthalate alternatives—such as diisononyl cyclohexane-1,2-dicarboxylate (DINCH)—are gaining traction but remain more expensive and

less widely available. Their adoption is uneven: Western Europe and North America lead due to regulatory pressure, while emerging markets rely on cheaper, less compliant substitutes, raising health and trade equity concerns. Labor conditions across this supply chain are a critical flashpoint. In China's polymer plants, workers face exposure to volatile organics and high-pressure processing environments, with documented cases of respiratory issues and dermatitis. Unions like the All-China Federation of Trade Unions advocate for improved safety, but enforcement varies. In Southeast Asia, where many intermediary chemical producers operate, labor rights are often weaker, and informal employment prevails. The lack of transparency in subcontracting layers—especially in dye and pigment manufacturing—complicates traceability and accountability. Climate policy is reshaping sourcing strategies. The European Union's Carbon Border Adjustment Mechanism (CBAM) will impose tariffs on carbon-intensive imports, incentivizing Playdough producers to source low-carbon feedstocks. This pressures suppliers to decarbonize: some ethylene plants are investing in green hydrogen and carbon capture, while acetic acid producers in India are transitioning to bio-based methanol. However, such shifts require capital-intensive retrofitting, favoring large firms over smaller suppliers and accelerating industry consolidation. Transportation logistics further expose vulnerabilities. Most raw materials travel via tankers through chokepoints like the Strait of Hormuz or Suez
