flooded platforms like 4chan, where memes depicted J.A. Johnstone as a shadowy hacker with a glowing cursor, whispering “The truth is free.” These images were low-resolution, intentionally grainy, reinforcing anonymity. Threads grew into sprawling lore: “J.A. Johnstone used to be a content librarian at Netflix,” one post claimed, “fired for refusing to monetize public domain films.” Another alleged he had built a decentralized index of all pirated educational content, offering it “without ads, no ads—just knowledge.” The narrative deepened with the introduction of the “Free S” designation. In Russian Telegram groups, it was framed as “Соблазнение без санкций” (“Freedom without penalties”), linking it to state-level distrust of centralized control. Technologically, the infrastructure was deceptively modest. The primary server cluster, identified by researchers at the Cyber Threat Alliance in 2023, consisted of six nodes hosted across jurisdictions with lax digital surveillance laws—Cyprus, Russia, and parts of Southeast Asia. These nodes rotated daily using Tor’s directory authorities, making tracking nearly impossible. The download protocol relied on a custom HTTP/2 handler that stripped cookies, disabled browser fingerprinting, and embedded a one-time challenge-response mechanism tied to a precomputed cryptographic puzzle.
