The economic incentive is potent: a single RLT device, priced between \$2,000 and \$15,000, can be deployed daily in outpatient settings, with recurring revenue from consumables (LED panels) and subscription-based software analytics. This has spurred a startup ecosystem where venture capital chases “disruptive” medical tech, often prioritizing speed-to-market over longitudinal safety data.

This has sparked regulatory pushback: the FTC fined several companies for deceptive "precancerous lesion clearance" claims, while the WHO's International Agency for Research on Cancer (IARC) issued a 2023 warning about unproven phototherapy in high-risk patients. Biologically, the risks are understudied. Unlike UV radiation, which induces direct DNA damage and is a proven carcinogen, RLT uses non-thermal photons. Proposed mechanisms—upregulation of anti-inflammatory cytokines (IL-10), enhancement of autophagy, and modulation of tumor suppressor pathways (p53 activation)—remain largely preclinical or inferred from indirect data. No long-term cohort studies track malignant transformation post-RLT use. A 2023 observational study in *Photomedicine and Laser Surgery* reported no immediate adverse events after 2,000 hours of RLT exposure, but acknowledged that "missing the forest for the trees: we lack data on delayed outcomes, especially in immunosuppressed individuals." Moreover, inconsistent device quality introduces variability. Cheap, unregulated LEDs may emit suboptimal wavelengths or insufficient irradiance, leading to inconsistent dosing. This "dose-response ambiguity" undermines reproducibility and erodes clinical trust. The FDA's 2022 guidance on LLLT

devices attempted to tighten standards, but enforcement remains uneven, especially in low- and middle-income countries where import regulations are lax.

Global Comparisons: From Australia's Sun-Intensive Model to Europe's Regulatory Cautiousness

Australia, a global epicenter of actinic keratosis due to its intense UV index and high fair-skin prevalence, has taken a divergent path. While RLT devices are available via private clinics, the national Rollout of SunSmart policies and widespread NHS-funded dermatology services prioritize evidence-based first-line therapies. However, in rural zones, where dermatologist access is limited, community health workers use portable RLT units under telemedicine supervision—an adaptive model gaining traction. In contrast, European Union countries maintain a stricter evidentiary gatekeeping. Germany's Robert Koch Institute prohibits RLT as a standalone treatment, requiring proof of efficacy in phase III trials. France, while cautious, permits off-label use under strict dermatologist supervision, with insurance reimbursement conditional on documented patient preference and lack of viable alternatives. These divergent approaches reflect deeper cultural and systemic factors: Australia's high sun exposure demands scalable, preventive tools, while European systems emphasize precaution and centralized oversight. Emerging economies face a different calculus. In India, South Africa, and parts of Southeast Asia, RLT is marketed as a "revolutionary at-home solution" for rural populations with minimal dermatologist access. Yet without robust regulatory enforcement, these markets risk premature adoption, potentially exacerbating health inequities through unproven treatments displacing proven, evidence-based care.

Long-Term Implications: Beyond the Lesion—Prevention, Surveillance, and Systemic Shifts

The integration of RLT into actinic keratosis management may herald longer-term transformations in dermatology and public health. However, deeper structural challenges persist. The skin cancer burden is projected to rise—by 2040, global actinic keratosis cases may exceed 30 million annually—driven by aging, ozone
