This framework gained traction during the 1980s, a decade defined by the rise of neoliberal economic policies and the digital dawn. Though OmniCorp eventually reversed course under public pressure, the incident underscored the fragility of institutional integrity even within codified standards. Legal risks remain acute. In 2020, *Standard 12*-aligned *Southeast Review* faced a defamation lawsuit in Indonesia over a story exposing corruption in infrastructure contracts.
