It is both a technical safeguard and a geopolitical signal: nations investing in enduring infrastructure project confidence in their long-term stability. Economic constraints further modulate these rules. In budget-constrained environments, the “simplified factor of safety” thumb—reducing load factors by 20% to cut material costs—becomes a common, though controversial, practice. While it lowers immediate expenditure, it risks underestimating extreme events, sparking debates about ethical responsibility.
