This perspective underscores a broader tension: how to preserve the integrity of expository preaching while remaining responsive to shifting ecclesial and societal landscapes. The pastoral dimension further complicates the sermon's role. In many Baptist communities, pastors serve not only as theologians but as counselors, conflict mediators, and community builders.
