In a 2019 WHO survey on malaria prevalence across 12 African nations, over 40% of local health districts reported expected cell counts below five in key demographic strata, rendering chi-square invalid. Analysts responded by adopting Fisher’s exact test or Bayesian alternatives, but institutional inertia delayed adoption, exposing a tension between statistical rigor and operational urgency. Geopolitically, chi-square applications have become tools of both governance and contestation. During the Cold War, both Western and Eastern blocs deployed the test to validate claims about societal well-being: literacy rates in Soviet bloc nations versus NATO states, agricultural yields under collectivization versus private farming models. These comparisons were rarely neutral. The U.S. Agency for International Development (USAID), for example, used chi-square analyses in its Green Revolution programs to assert superiority of hybrid seed varieties, often downplaying ecological or socioeconomic costs documented by local scholars. Such uses sparked epistemic debates—what counts as valid evidence?—and underscored how statistical tools embed power structures. This misuse has fueled calls for reform: the American Statistical Association’s 2023 guidelines now recommend supplementing chi-square outputs with Bayesian posterior probabilities and sensitivity analyses, especially in high-stakes decisions. Globally, regulatory and institutional responses vary. The European Union’s General Data Protection Regulation (GDPR) implicitly pressures responsible use by requiring data minimization and purpose limitation—constraints that indirectly shape how chi-square analyses are conducted.
