The same infrastructure used to move contraband—remote airstrips, unmarked convoys, encrypted comms—mirrored patterns seen in Mexican cartel logistics and Eastern European cybercrime syndicates. Idaho, long seen as a stable, low-visibility state, became a node in a network where local corruption could accelerate global criminal flows. For the Idaho penal system, the photos represented a crisis of legitimacy. Decades of underfunding, understaffing, and political interference had eroded accountability. The
