Teachers’ unions and academic institutions criticized the lack of transparency in content vetting processes, fearing that political influence might compromise educational quality. The directive also accelerated digital transformation: e-learning platforms, AI-driven personalization tools, and interactive modules became essential to deliver inclusive content at scale. Beyond textbooks, the directive reshaped ancillary industries—edtech startups, assessment firms, and academic consulting—each adapting to new standards of equity and representation. The market now rewards innovation in inclusive design, but risks entrenching monopolistic tendencies if access to resources remains concentrated.
