From 2004 to 2010, he led a federally funded consortium, the National Center for Animal-Assisted Intervention (NCAAI), which brought together clinicians, ethicists, legal scholars, and animal behaviorists to develop standardized protocols. The NCAAI’s 2008 white paper, ‘Defining the Therapeutic Role of ESAs,’ proposed a tripartite framework: animal suitability (temperament, health, training level), handler certification, and clinical oversight. This framework sought to balance accessibility with accountability—ensuring that ESAs were not merely companions but validated therapeutic assets. The report became a foundational text, cited in subsequent revisions of Fair Housing Act (FHA) interpretations and influencing Department of Housing and Urban Development (HUD) guidance in 2010, which began recognizing ESAs in housing applications with appropriate documentation. But Welch’s influence extended beyond policy. His 2012 monograph, ‘The Quiet Healers: Emotional Support Animals in the Age of Trauma,’ redefined public understanding. Drawing on ethnographic fieldwork in disaster zones, refugee resettlement centers, and urban mental health clinics, Welch argued that ESAs functioned not just as individual comforters but as

socio-cultural mediators—bridging linguistic, cultural, and emotional divides. In post-Katrina New Orleans, he documented how therapy dogs integrated into community healing circles, enabling survivors to express grief in nonverbal ways, bypassing the trauma of direct interrogation. In refugee camps in Jordan, ESAs—often shelter animals humanized through care—helped displaced youth reestablish trust in human connection. These narratives reframed ESAs from fringe tools to vital components of psychosocial infrastructure. Economically, the rise of ESAs catalyzed a new industry. By 2015, the global animal-assisted therapy market exceeded \$14 billion, with ESAs contributing nearly 30% of growth. Startups emerged offering ESA certification services, mobile apps for tracking animal behavior, and training platforms certified under NCAAI standards. In the U.S., companies like Pet Partners and Emotional Support Animal Registry expanded their client bases, while airlines began revising policies to accommodate ESA transport—though inconsistent and often contested. Welch, skeptical of commercialization, cautioned against commodification, advocating instead for a regulated, clinically grounded ecosystem. His 2017 critique in *\*The Lancet Psychiatry\** warned: “
