In contrast, the U.S. model, as exemplified by Miller Levine, often isolates molecular detail from its broader context—a divergence that reflects deeper cultural attitudes toward science: as a technical toolkit rather than a narrative of interconnection. Looking ahead, the geopolitical stakes of biology education will grow. As nations compete for leadership in biomanufacturing, disease surveillance, and climate adaptation, the quality and framing of science curricula become strategic assets.
