Japan's Digital Content Act, revised in 2021, encourages voluntary licensing agreements between platforms and publishers, supported by public subsidies but without mandatory state licenses. Washington's model is distinctive in its hybrid design: it combines conditional permission with state-administered revenue distribution, preserving market dynamics while embedding public accountability.
