"It sets expectations, creates accountability, and signals to investors that we are serious about standards." His confidence rests on measurable outcomes: a 40% reduction in formal labor disputes since 2020 and increased foreign investment in regulated sectors. Yet critics highlight hidden costs. Dr. Elena Marquez, a sociologist specializing in post-colonial governance, warns of "institutional path dependence." "Once a framework is codified, it becomes self-reinforcing," she explains. "Policies evolve slowly, often reacting to crises rather than anticipating change." This rigidity, she argues, perpetuates the marginalization of vulnerable groups—women,

migrants, and informal workers—who lack the means to navigate bureaucratic systems.
