In Nigeria, for instance, interfaith prayer coalitions rally around promises of peace and justice amid religious and

ethnic conflict, leveraging divine word to legitimize civic action. In South Korea, the explosive growth of megachurches rooted in promise-centered theology fuels both economic dynamism and political influence, with prayer meetings doubling as community hubs and soft-power platforms. These networks are not apolitical; they are arenas of real influence, shaping policy discourse, social cohesion, and even electoral outcomes. The prosperity gospel, amplified by global media, has drawn sharp criticism: is it a distortion of faith, exploiting vulnerability for gain? In Brazil and the U.S., megachurch leaders wielding divine promises as political endorsements or economic mandates have fueled polarization. Yet, defenders counter that such expressions reflect authentic spiritual experience, not commercial manipulation. The divide reflects deeper cultural struggles—between individualism and community, between material security and transcendent meaning. In contexts of poverty, promises of divine provision offer more than comfort: they validate dignity, redefine hope, and challenge systemic neglect. As theologian Willie Jennings observes, ‘The promise is a counter-narrative to the myth of self-made destiny, reminding the marginalized that their worth is not contingent on productivity.’

Risks are manifold. In volatile regions, organized prayer movements can be co-opted by political actors, transforming spiritual solidarity into sectarian mobilization. The 2023 unrest in Sudan, where religious gatherings became flashpoints, illustrates how divine promises—once unifying—can inflame divisions when interpreted through zero-sum lenses. Similarly, digital evangelism amplifies reach but also spreads disinformation: false promises of miracles or divine protection circulate rapidly, endangering vulnerable believers. The viral spread of unverified claims—‘Your debt is forgiven by God’—can lead to financial loss, psychological harm, or exploitation. Faith leaders thus face a dual burden: preserving the sanctity of promise while guarding against manipulation. Ethical frameworks, such as the Global Ethical Standards for Faith-Based Media, are emerging, demanding transparency, accountability, and pastoral care as non-negotiable pillars.

Comparative religious studies reveal parallel dynamics beyond Christianity. In Hinduism, **shraddha** (faithful trust) in **dharma** and divine vows sustains ritual and moral life across millennia. Buddhism, while non-theistic, embraces promise-like **sankhara** (intent) and **bodhicitta** (enlightened resolve), where commitment to compassion becomes a path through suffering.
