Its systemic, effects-based doctrine has driven a shift from **platform-centric** to **system-of-systems** acquisition. For example, the F-35's design—modular, open-architecture, and networked—directly reflects 64-4's call for interoperable, multi-domain capabilities. Similarly, the development of the Long-Range Standoff (LRS) weapon system and the Air-Launched Cruise Missile (ALCM) modernization traces back to the manual's prescriptions for standoff precision and strategic reach. Unmanned systems, particularly high-altitude long-endurance (HALE) drones and autonomous strike packages, owe much to 64-4's early advocacy for **networked effects**. The doctrinal embrace of information dominance and effects integration has sparked intense debate over *autonomy in lethal decision-making*.
